FORENSIC NURSES WEEK

EDUCATION

The Association offers education through live trainings, our Online Learning Center, our grant projects, and our clinical partner sites.

ONLINE LEARNING

In 2019, IAFN's Online Learning Center saw an explosion in use, issuing 5,701 certificates compared to the prior year's 2,134. The most popular courses remain our 40-hour Adult/ Adolescent Sexual Assault Nurse Examiner course and the Pediatric/Adolescent Sexual Assault Nurse Examiner course.

APPROVERSHIP

The IAFN's Approver Unit completed its third year of approving forensic continuing nursing education programs that met the highest standards of educational planning, implementation, and evaluation as set forth by the American Nurses Credentialing Center's Commission on Accreditation.

CONFERENCE

2019 was a banner year, with a 30% increase in the number of attendees to our annual International Conference on Forensic Nursing Science and Practice in New Orleans, Louisiana. More than 1200 people attended sessions, choosing from 143 presenters. Attendees earned up to 22 contact hours.

Additionally, IAFN launched a conference app for attendees, which offered note taking, networking, CE tracking, and schedule management all from the convenience of their phones.



GLOBAL HIGHLIGHTS

American Samoa: IAFN provided a 40-hour Adolescent/Adult SANE training to doctors and nurses in America Samoa in August 2019. While there, IAFN coordinated with advocacy, law enforcement, and prosecutors to provide training and offer networking opportunities between the clinicians and the community partners. A clinical skills training will follow in early 2020.





SPECIAL PROJECT: ADDRESSING GENDER-BASED VIOLENCE IN MEXICO

The IAFN was a partnering organization with the International Association of Chiefs of Police (IACP) for a multi-year project addressing sexual and gender-based violence in Mexico funded by the US Department of State – INL Merida Initiative. The IAFN provided education on intimate partner violence, neurobiology of trauma, strangulation, and sexual violence for five delegations visiting from Mexico. Delegations included judges, prosecutors, police managers, psychologists, and Women's Justice Centers personnel. After initial education, participants visited US communities and interacted with functioning Sexual Assault Response Teams to experience a multidisciplinary community approach to sexual and gender-based violence.

SEXUAL ASSAULT FORENSIC EXAM TECHNICAL ASSISTANCE PROJECT - ADULT AND PEDIATRIC

For the 14th year, the Association continued to provide education and technical assistance regarding the *National Protocol for Sexual Assault Medical Forensic Examinations, 2nd Edition* through the SAFEta Project, funded by the US Department of Justice, Office on Violence Against Women. 2019 marked the third year of education and technical assistance regarding the *National Protocol for Sexual Abuse Medical Forensic Examinations - Pediatric*.

The SAFEta project supports formal and informal local, state, and national multidisciplinary efforts to coordinate the response of healthcare professionals, law enforcement officers, prosecutors, and victim service providers who respond to sexual assault.

Highlights from 2019 include:

- Reviewed state-level protocols and practices in Ohio, Vermont, and Virginia
- Provided training and techinical assistance to Michigan State University's Relationship and Sexual Misconduct Task Force as they began building their unique campus-based community SANE program
- Worked with AEquitas to revise the National Prosecution of Domestic Violence in Indian Country curriculum
- Partnered with the National Advocacy Center to provide our popular SANE testimony training. More than 140 people applied for the 40 available slots.
- Began monthly meetings for Statewide SANE coordinators to identify priority areas for training and technical assistance

SAFETA PROJECT (CONTINUED)

- Provided sexual assault medical forensic exam training for the Navajo and surrounding Arizona tribes
- At the request of the US DOJ, Office on Violence Against Women (OVW), IAFN
 hosted a webinar on the Forensic-Medical and Advocacy Services for Tribes'
 request for proposals and provided technical assistance to those applying.
- Presented at numerous conferences and events, including the National SART Leadership conference, the International Symposium on Child Abuse, and OVW's Improving the Criminal Justice Response grantee orientation
- Worked with the Prison Rape Elimination Act Resource Center and Impact Justice to present on collaboration in prison rape cases
- Continued our work with the National Human Trafficking Training and Technical Assistance Center (NHTTAC) to present the SOAR for SANE Training
- Presented a webinar for the SAKI (Sexual Assault Kit Initiative) project with AEquitas on sexual assault on Forensic Evidence and Chain of Custody

EXAM PAYMENT PROJECT

This OVW-funded project provides training and technical assistance related to improving access to and payment for sexual assault medical forensic examinations, including examinations of patients who do not wish to report the crime to law enforcement at the time of the exam.

In 2019, the project provided six trainings and developed a comprehensive set of web pages. These include a map that links to every state, territory, the District of Columbia, and the Military. Each page includes a summary of that state's medical forensic exam billing and payment process, coordination with healthcare, and various links to crime victims compensation information.

GRANT PROJECTS

TRAINING STANDARDS PROJECT

In 2019, IAFN began work on the OVW-funded Training Standards Curriculum Project with the goal of creating an interactive online learning program for non-SANE/SAFE healthcare clinicians (nurses, physicians, PAs, and general ER staff) who provide emergency health care for victims of sexual assault. IAFN collaborated with multiple partnering agencies to develop content for these clinicians and facilities that are unable to obtain SANE/SAFE training or unable to support creating and sustaining a SANE/SAFE Program. This curriculum incorporates the *Appendix C: Minimum Training Recommendations* from the *National Training Standards for Sexual Assault Medical Forensic Examiners (2nd ed)*.

NATIONAL INDIAN COUNTRY CLEARINGHOUSE ON SEXUAL ASSAULT (NICCSA)

In 2019, IAFN was awarded funding for an OVW Special Initiative as a part of the congressionally mandated National Indian Country Clearinghouse on Sexual Assault (NICCSA). The project is a component of a larger NICCSA project, and focuses on sexual assault in American Indian and Alaska Native communities. The focus for IAFN's NICCSA project is targeted mainly in Alaska Native communities, where the response to sexual assault is limited due to geographic isolation and limited resources. Working in concert with the OVW Tribal Unit project manager, IAFN staff attended the Alaska Project Implementation workshop in December in Anchorage, AK. This project was still in the planning stages at the close of 2019.

TELESAFE

In September 2019, IAFN received a grant to provide technical assistance to four OVC demonstration sites using Telehealth to provide sexual assault forensic exams. IAFN began by setting up private electronic communities for each site to allow for communication, discussion, and resource distribution. After beginning monthly videoconferencing meetings, it quickly became clear that sites varied significantly in their equipment, policies, clinical training needs, but also in the number and location of the clinical sites they planned to launch. Monthly meetings were established with OVC and the grant subject matter expert partners. In December 2019, IAFN began developing a needs assessment. The results will inform future work.

TRIBAL FORENSIC HEALTHCARE TRAINING PROJECT

Since March 2013, the Indian Health Service has contracted with IAFN to develop, deliver, and evaluate in-person and web-based training related to the identification, collection, and preservation of medical forensic evidence obtained during the treatment of victims of sexual and domestic violence. The Tribal Forensic Healthcare Training project provides training for Sexual Assault Examiner, Pediatric Sexual Abuse Examiner, Sexual Assault Clinical Skills, Pediatric Sexual Abuse Clinical Skills, Intimate Partner Violence Examiner, and Intimate Partner Violence Screening, as well as quarterly webinars on related topics.

In 2019. the project hosted a 1/2 day course from Dr. Jacqueline Campbell on her Danger Assessment. Upon completion, attendees were qualified to take the Danger Assessment Administration exam. IHS also provided funding for 400 IHS-employed medical professionals to take the Danger Assessment Certification Examination.

SPECIAL PROJECT: TELEMEDICINE IN INDIAN COUNTRY

The Tribal Forensic Healthcare partnered with Our Kids in Nashville, TN to launch a Telemedicine Program in 2016. This project has two components: an expert peer review process and expert case review.

EXPERT PEER REVIEW consists of a monthly review of cases between Our Kids, Four Directions Clinic, and Pine Ridge Hospital. In 2019, 12 peer reviews panels reviewed 79 cases.

EXPERT CASE REVIEW provides real-time review of case-specific information with acute and non-acute patients. These reviews are performed with the use of telemedicine software, Second Opinion, during case consultation. Our Kids provides 24/7 availability to Four Directions Clinic and Pine Ridge Hospital, including working with local agencies by using teleconferencing equipment.
